## General lending terms and conditions

### Definition of the trailer

A trailer refers to a closed trailer towed behind a vehicle with all additional parts and equipment.

### II. Use of the trailer

The borrowed trailer can only be used by the borrower. The trailer can only be used within the borders of Finland. The borrower is responsible for ensuring that valid regulations concerning the borrowed trailer and its use are complied with. The borrower also complies with valid parking regulations. The borrower is responsible for any fines and fees due to any violations of parking regulations or other use. The trailer may contain a functioning GPS locator.

### III. Handling the equipment

The borrower must take good care of the trailer. The borrower is responsible for damage caused by deliberate or careless use. In case of damage, the borrower does not have the right to repair the trailer. Any damage to the user's vehicle is the responsibility of the user.

### IV. Insurance terms and conditions

The borrowed trailer is fully insured with a deductible amount of EUR 200. (in case of damage compensation, the deductible amount is paid to Enter Ventures Ltd)

# V. Returning the borrowed trailer

The borrowed trailer must be returned to the same location from where it was picked up. If the borrowed trailer is returned later than the agreed return time without the lender's permission, Aalto University Student Union (AYY) is entitled to charge rental compensation\* and, if necessary, demand compensation for damage caused to the lender. Costs for collecting and transferring the trailer left to other than the agreed location are charged from the borrower.
